This past year, 2012, marked the 34th year that Citizen Advocates has been matching partners and advocates. From the beginning in 1978, we've striven to help create freely given friendships (partnerships) that will last as long as friendships remain important. With your help we've been able to do this hundreds of times over the past several decades. And with your continued help we'll redouble our efforts in 2013, our fourth decade of service to Washington County communities.

This is an accomplishment for our organization given the decline in charitable giving as the economy struggled over the last few years and being one of a few non-profits that does not receive any government funding.

DID YOU KNOW? A message to our donors from our Program Coordinator

OUR PROGRAM COORDINATOR Jessie

Take a few moments to think about all the people in your life. Write them down. Start by listing your family and close friends. Next list all your friends, the ones that aren't your first phone call when something happens, but that you do share parts of your life with. When you are finished with that, list your acquaintances, those people you know and wave hi to ... maybe you don't know their name, but you see them everyday ... list them too. If you still have room on your sheet, write the people in your life that are paid to be there, doctors, teachers, the coffee shop barista, the check out person you see each week.

For many of us, when you complete the exercise above, our list is long. We realize how many people we call friends and how important they are to our lives. They are the people we call on when good and bad things happen. They are the people we call when we need to get a suggestion for a new doctor, cable provider, auto shop. They are the people that we rely on to share our life's journey.

Recently a woman that runs multiple group homes in Washington County approached Citizen Advocates about finding advocates for some of the people living in their homes. We sat down and met with each person and while I got to know the people, over and over again the staff said that they were concerned about these people because they had no one, outside of the staff, to speak up for them. One of the men we visited with is the last surviving member of his family; his parents and sibling are gone. The people he lives with, that he spends his day with, are paid to be there.

Rethink about the exercise above, but instead of listing your friends, list the people in the man's life I just mentioned. He has no close friends or family. His friends and acquaintances are his housemates and co-workers, all of varying abilities, put together by staff, not by his choice. The longest list he has is the paid people in his life. And as we all know, they come and go, after all, it is a job for them.

A message to our donors from the Executive Director, Mark Brunner

WE WANT YOU TO KNOW

WE MADE 27 CITIZEN ADVOCATE MATCHES IN 2012.

On average it takes between six and eight months to make a match. Because partners are vulnerable we take an appropriate amount of time to find just the right advocate. All advocates must pass stringent background checks prior to meeting a potential partner. This year we are actively following 49 matches in the Washington County area. (Many matches chose to remain private and we are careful not to impose. We only follow matches that choose to stay in touch with us.) We closed 1 match in 2012 due to death or an advocate or partner that has moved to another area of the county.

2 Community Connections matches established benefitting 9 individuals.

3 Community Partners programs continue in Germantown, Kewaskum, and West Bend East/West High Schools.

Our office space continues as a community resource for dozens of individuals with developmental disabilities spending time at Our Place.

A partner continues to work in the CA office.

3 new peer matches in Washington County in 2012.

WE WANT YOU TO KNOW

78% of your investment was invested in Program in 2012.

According to our auditor, Dieztler, Kieckhafer and Hauser, 22% of our income is normally spent on administrative costs. That means 80% of your investment in our Citizen Advocates program is invested in program support and program growth. We are a small program with a small staff. Our income budget is slightly more than \$100,000 a year. A small program will normally have a higher salary to income ratio. We are proud to tell you that 78% of the investments we receive from donors like you are reinvested in program. And, that's the way we want to keep it. 2012 was again a very difficult financial year for most nonprofits; and it was no different for Citizen Advocates. We saw our income stream decrease by nearly 8% over 2011 and nearly 11% over 2010. Investments continue to decline from businesses, organizations and even some of our sustaining, foundation donors. We continued to cut expenses over the course of these last three years, but are having a difficult time matching the decline in income. We reduced our overhead by 23% in 2012 by moving offices and reducing utilities. We go into 2013, however, with a healthy and growing program and, thankfully, a budget that is manageable. Thank you for your consistent support. We couldn't do it without you.

WE CHANGED OUR NAME IN 2012 TO CITIZEN ADVOCATES, BUT OUR MISSION REMAINS CONSTANT.

Although we changed our name from Citizen Advocacy to Citizen Advocates in 2012, we continue to be an independent, non-profit organization that creates and supports one-on-one relationships between volunteer advocates and groups of advocates and people with disabilities. Established in 1978, Citizen Advocates has provided and supported over 350 relationships, some over 30 years long. Our nonprofit organization is funded by foundation grants, United Way, fundraisers, donations from individuals and businesses, and contributions from various community, civic, and religious organizations. Our continuing mission is to "create relationships which make a positive difference in the lives of persons with disabilities." The logo may have changed and our name slightly, but we remain dedicated to the mission of citizen advocacy as established over 35 years ago in Washington County.
