



## A Fortunate Connection

*In 2011 Citizen Advocacy had a new name (Citizen Advocates), new logo, updated mission statement and we began to look for ways that we could have a greater impact in our community. The idea of group advocacy came from this desire to create more opportunities for people in the community to learn about who we were and to see that they could be advocates for someone with disabilities.*

We were fortunate to connect with a small group of people from Kettlebrook Church who were interested in being the first to on this new idea. We matched them with a group of people with disabilities that were living mostly independently in one apartment building.

We all went into the first gathering in the fall of 2011

with a lot of questions and few answers. No one knew what to expect or what the outcome would be. The small Kettlebrook group began to set up monthly outings and offer them to the residents of the apartment building. Some outings were well received, a few others were met with little interest. But the group persisted and made a commitment to continue for another year.

This past month I was invited to dinner with two of the couples from the Kettlebrook small group. They were each interested in talking about becoming one on one advocates for residents in the apartment building. As they told stories of their group outings over the last 5 years, it was very evident that advocacy is already taking place. They already considered the individuals that lived in the apartment building as a part of circle of friends and they value each person in the group for what they bring to the group.

Moving towards a one on one match just seems like a natural next step for them.

A few days after this dinner, I was invited to attend a Baptism Service with Kettlebrook Church. Many of the residents of the apartment building have been attending Kettlebrook services and 4 had chosen to be baptized. (Attending church and being baptized was never a goal of the group match, but was a choice many have made because of the relationships they have made.) The service and baptism were very cool to be there to see, but to me the greatest part was seeing the members of the small group supporting, encouraging and standing beside each other as people who care deeply for each other.

When we started this new idea in 2011, we didn't know what the outcome would be. Five years later, it is so much better than we could have imagined!

## SHOOTING FOR A DIFFERENCE 2016



Over 250 shooters participated in this year's *Shooting For A Difference* fundraising event at Wild Wings Sportsman's Club in Campbellsport the weekend of August 19-21. We set a goal to raise \$17,000 this year to support our *Youth Connections* advocacy programs and came very close to realizing that very liberal goal. We raised over \$16,000—\$7,000 more than our 2015 event and \$10,000 more than the inaugural even in 2014. Many thanks to the families and groups of area shooters who showed up on a very hot, humid and rainy weekend, as well as to the area individual and business sponsors who sponsored the raffles and the shooting stations. Kudos as well to the many CA volunteers who braved the elements to make sure that our independently funded program remains funded without funding from state, federal or local community resources.

The workshop was held on October 13 and Wolfensberger stayed overnight to speak at our Annual Dinner on October 14. We were indeed fortunate to have Dr. Wolfensberger here, as it turned out he passed away in February of 2009, making his 2006 visit a one-time opportunity for us.
