The girl in the picture is a peer advocate and when she saw the boy under the table, she grabbed a game and joined him where he was. A simple gesture of kindness ... a powerful message of inclusion.

The picture with the toilet paper zombie ... a simple activity that many of us have taken a part of. See the young man on the right? His teachers that were with the group said he never smiles for pictures. Today when I saw
